Swift TV Commercial Rollout Accelerates with 2,700+ Screens Installed in 7 Weeks

Highlights

- **Commercial scale Swift TV deployment underway:** 2,758 Swift TV screens installed across 7 customer sites within 7 weeks
- **Recurring revenue:** Commences as sites are commissioned
- **Execution phase:** Swift TV has entered commercial rollout and expansion, transitioning from development to revenue-generating deployment
- **5,000 additional Swift TV units** ordered from Google certified supplier to support near-term deployment pipeline

Swift TV Ltd (ASX: STV) ("Swift" or "the Company") is pleased to provide an update on the commercial rollout of its new Swift TV product, with installations now underway across multiple contracted customer sites in the Resources and Aged Care sectors.

Deployments include a mix of new enterprise customers and upgrades within Swift's existing customer base, including global oil and gas operators and leading aged care providers.

As at the date of this announcement, **2,758 Swift TV screens have been installed across 7 sites within a 7-week period, demonstrating rapid deployment capability.**

A further 8 sites are scheduled for completion by 1 June 2026, representing continued near-term rollout momentum.

These deployments represent the initial phase of Swift TV commercialisation, with recurring subscription revenue expected to commence or expand as each site is commissioned.

Swift TV deployments are typically supported by multi-year contracts, providing visibility over future recurring revenue streams.

Swift TV represents the culmination of a multi-year investment in product development, with the business now entering a scaled commercial rollout phase.

To support expected demand, Swift has placed an order for an additional 5,000 units, positioning the Company to continue deploying across its contracted pipeline.
